2. COVENANTS OF THE PARTIES

b. Role and Responsibilities of Ashiraj Overseas Education Consultants will be

- Ashiraj will maintain regular contact and provide information, including program brochures and leaflets.
- Ashiraj maintains regular contacts with the appropriate processing of the foreign company on behalf of the students.
- Ashiraj assisting the students in preparing & processing the visa applications.
- Ashiraj assisting the students for visas and guiding them by conducting mock interviews & Visa counseling.
- Ashiraj will be providing pre - departure orientation to the students after the approval of visa. And also provide assistance and support through its partner companies, to the students when needed.
- Ashiraj will resolve all issues of the students encountered by them at their destination. Furthermore, Ashiraj will work with the local partner or companies for resolving issues.
- Ashiraj will correspond and assist the students to arrange a suitable Insurance policy, insuring the concerned students against any and all risks arising out of any wrongful act, injury etc. which the student might encounter during the internship in Mauritius. the company and or its employees. Further, the Consultant and its representatives will extend all cooperation and help any such student and /or its family in any such eventual if to ensure the safety of the students at all given times during their tenure of the internship. Neither **AMICHM** nor its employees will be responsible for the same.

3. FINANCIAL ARRANGEMENTS

The Parties acknowledge that in the absence of any specific agreement in writing to the contrary, each Party will be responsible for its own costs and expenses in establishing and conducting programs and activities contemplated under this MOU, including without limitation its own costs and expenses in travel and accommodation.

4. INTELLECTUAL PROPERTY RIGHTS

The Parties agree that the ownership of and any other rights relating to intellectual property arising from or in connection with any program or activity under this Memorandum of Understanding shall be determined on a case-by-case basis and shall therefore be specified and agreed for each such program or activity in a separate written agreement between the parties.

5. CONFIDENTIALITY

The Parties agree and undertake to keep confidential at all times any information or data that may be exchanged, acquired, or shared in connection with any program or activity conducted pursuant to this MOU, except where the same is already in public domain.

6. DURATION AND TERMINATION

- a. This MoU shall take effect on and from the date of execution of this MoU and shall continue to be effective for a period of Three (3) years and may be extended for such further period as may be agreed by the parties in writing.
- b. Notwithstanding clause 6 (1) above, this MoU may be terminated by either party giving written notice to the other at least One (1) months prior to the proposed date of termination.
- c. Notwithstanding clause 6 (2) above, the provisions of this MoU or any other written agreement in respect of any on-going exchange program or any other form of cooperative activity under this MoU shall continue to apply until their completion unless both Parties mutually agree in writing to the earlier termination of the program or cooperative activity.

7. FORCE MAJEUR

Notwithstanding any provision to the contrary in this MOU, neither Party shall be liable for any delay in performing its obligations under this MOU, if such delay or disruption is caused by circumstances beyond its reasonable control to prevent or mitigate as a result of any accidents; acts of war, acts of internal aggression, violence, arson, vandalism, acts of wanton destruction; due to Act of God, Pandemic, war, riot, civil commotion, unforeseen accident, fire flood or storm or terrorist attack; any change of any laws, by-laws, policies, guidelines, rules or regulations of the respective governments of the Parties hereto or any applicable judicial pronouncements or decisions, or any other event (hereinafter a "force Majeure"), accordingly the obligations of that Party under this MOU shall be suspended for the duration that the disruption due to the Force Majeure prevents such Party from carrying out its business activities. However the affected Party may notify the happening of such force majeure event to the other Party.

PROVIDED ALWAYS the decision whether to initiate and/or implement any program or activity shall be at the sole discretion of each Party.

9. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of India and shall be subject to the exclusive jurisdiction of the courts in Mumbai.

10. NOTICE

- a. The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MOU and to draw up a programs or activities to be implemented under this MOU.
- b. Every notice, request or any other communication required or permitted to be given pursuant to this MOU shall be in writing, in English and delivered personally or sent by registered or certified post via air mail or by courier or email (which shall be acknowledged by the other Party) to the Parties at the addresses as stated below:
